BROTHER JACKSON • 2021 FROZEN SEMEN CONTRACT

The undersigned Mare Owner hereby agrees on this _____ day of _____, 2021, to breed the mare named below to the Stallion BROTHER JACKSON for the 2021 season (February 1 – July 15) subject to the following conditions:

| <ol style="list-style-type: none"> The Fees of \$500.00 booking fee (non-refundable) and a \$1,500.00 stallion service fee, and the \$500 Frozen Transported Semen Fee (Plus the Federal Express shipping fee) This completed contract, stallion service contract, shipping information contract and a copy of the mare's registration papers must be received along with all fees, prior to semen being shipped. All Frozen Semen Contracts must be accompanied by a Stallion Service Contract and a Shipping Information on Transported Semen Contract. All frozen semen will be shipped directly from the veterinarian's office where it is stored and has been stamped with approval. Each shipment includes two doses of frozen semen (one dose for pre ovulation and one for post ovulation, which is 8 and 8). It is understood that all subsequent shipments, if necessary, must be paid in advance by owner Under this contract a live foal is guaranteed. It is agreed that a "live foal" is defined as one that will stand and nurse without assistance after foaling. If the foal is born dead or Mare is found not to be in foal, it is the Owner's responsibility to notify Ken Wold Training Stables & Stallion Services, Ken & Ramona Wold, within seven (7) days. A statement must accompany this notice from a licensed veterinarian. In such case, return privileges will be available the following year, 2022, only. If Owner fails to return the Mare for rebreeding the following year, then any and all fees paid shall be forfeited, the right to a rebreed is canceled, and the stallion owner and/or Ken Wold Training Stables & Stallion Services, Ken & Ramona Wold, is released from all further obligation of this contract. If Mare dies or becomes unfit to breed, Owner may return during this season or the following season, 2022, with a substitute mare approved by the stallion owner, without an additional Stallion Service fee, (note: all rebreeds will need to pay an additional booking fee of \$500 to breed another year. One booking fee per mare per year. It is further understood that should the Stallion die, or become unfit for service for any reason, the contract will be honored until the subsequent supply of frozen semen is depleted, after which, this contract will become null and void and both parties are relieved of any further obligation hereunder. Frozen semen will be shipped according to the availability of shipping containers and in the order that we are notified. There is no guarantee of availability of shipping containers. All orders need to be made 5 days in advance, no exceptions. Ken Wold Training Stables & Stallion Services, Ken & Ramona Wold, only assumes responsibility to ship frozen semen in viable condition and shall not be held liable for contamination of semen during and after shipment, loss of viability, or any costs arising from shipments delayed, damaged or lost in transit. Ken Wold Training Stables & Stallion Services, Ken & Ramona Wold, does not guarantee the fertility of any stallion. Every effort should be made to inseminate the mare six hours prior to and/or six hours post ovulation. Owner agrees to use all frozen semen provided by this agreement for the mare named in this agreement, and no other. <u>All Frozen shipments, including International shipments will be charged actual shipping and duty fees.</u> It is imperative that the shipping container be returned to sender within three (3) days after the date of delivery (i.e. received on Monday must be returned Thursday). All containers will be insured for \$2,000.00 upon shipment to veterinarian and should be shipped back to sender with the same amount of insurance. Owner will be charged a \$100.00 per day late charge. Late charges will be applied to Owner's account and must be paid prior to any subsequent shipments. The shipping container and its components must be returned complete and in good condition. If any components are damaged or missing, the cost of replacement will be charged to Owner's account. Should Owner fail to return the container, Owner agrees to pay for its value of \$2,000.00. A deposit of \$2,000.00 will be placed on all international shipments and refunded upon return of the shipping container. All Frozen Semen will only be shipped Federal Express overnight. Mare owners will be responsible to pay \$500 for Straws plus the cost of Federal Express shipping fees. All Fees must be paid in full prior to semen being sent. A "breeders certificate" will be issued upon notification of the birth of the foal, only if all fees are paid, including any past due bills on any horse(s) owned by the Owner. | | |
