2023 BROTHER JACKSON COOLED or FROZEN TRANSPORTED SEMEN CONTRACT

The undersigned Mare Owner hereby agrees on this _____ day of _____, 202__, to breed the mare named below to the Stallion BROTHER JACKSON, AQHA Registration number 5313039 for the 2023 season (February 27 – July 14) subject to the following conditions:

The Stallion Service Fee is \$2,000.00, (which includes a non-refundable \$500.00 booking fee) An additionAI \$500 shipped semen fee, (courier fee of \$150 is included) will be charged for Brother Jackson semen, as we will be shipping semen Counter to Counter. International shipments will be \$500 plus the cost of the shipment. This completed contract, a stallion service contract, a shipping contract, and a copy of Mare's registration papers must be received along with the breeding fee, booking fee and shipped semen fee, prior to semen being shipped. If semen is picked up at the ranch the shipped semen fee is waived. Each cycle will constitute a semen processing fee of \$500 per collection. Breeding season starts February 27 and ends July 14. We collect semen from our stallions Monday, Wednesday and Friday and some weekend days with special circumstances. It is the mare owner's responsibility to call us and find out the collection days for the week. Mare owners will be charged \$500. Mare owners will be charged the cost of shipping is special requests are made (ie. First overnight etc.). The shipping charge is in addition to the stallion service fee. This applies to cooled transported semen only. Frozen semen is available upon request. Frozen semen fees are \$650 plus the cost of the actual shipment, as well as semen transfer fees. Our office must be given a 48 hour notice before shipping frozen semen - as our dry shipper must be charged. All forms need to be paid in advance of requesting semen. All semen must be shipped to a licensed veterinarian and must be requested by a veterinarian.

1. It is understood that all subsequent shipments, if necessary, must be paid in advance by Owner of mare at \$500 per shipment.
2. Under this contract a live foal is guaranteed. It is agreed that a "live foal" is defined as one that will stand and nurse without assistance after foaling. If the foal is born dead or Mare is found to not be in foal, it is Owner's responsibility to notify Ken Wold Training Stables & Stallion Services, Ken & Ramona Wold within seven (7) days. A statement must accompany this notice from a licensed veterinarian. In such case, **return privileges will be available the following year, 2024, only.** If Mare is to be returned the following year, another booking fee of \$500.00 will be due prior to Mare being rebred. Breeding privileges do not extend to the 2025 season. **The breeding fee will not be refunded.**
3. If Owner fails to return Mare for rebreeding the following year then any and all fees paid shall be forfeited, the right to a rebreed is canceled, and the stallion owner Dan Perez, and/or Ken Wold Training Stables & Stallion Services, Ken & Ramona Wold is released from all further obligation of this contract.
4. If Mare dies or becomes unfit to breed, Owner may return during this season or the following season, 2024, with a substitute mare approved by the stallion owner, without an additional breeding fee (a new booking fee of \$500 will be due).
5. It is further understood that should the Stallion die, or become unfit for service for any reason, then this contract will become null and void and both parties are relieved of any further obligation hereunder.
6. BROTHER JACKSON will be collected Monday, Wednesday and Friday and some weekend days with special circumstances. There will be no exceptions. It is the responsibility of Owner and his/her veterinarian to confirm our shipping days. There is no guarantee of availability of cooled semen. It is also understood, that due to the extensive show schedules of performance horse stallions, Ken Wold Training Stables & Stallion Services, Ken & Ramona Wold and Dan Perez is not responsible if Stallion is unavailable for collection during the breeding season. Please call our office prior to artificially cycling your mare. We will notify you of his availability for collections prior to your planned synchronizing.
7. Ken Wold Training Stables & Stallion Services, Ken & Ramona Wold and Dan Perez only assumes responsibility to ship semen in viable condition and shall not be held liable for contamination of semen during and after shipment, loss of viability, or any costs arising from shipments delayed, damaged, or lost in transit. Ken Wold Training Stables & Stallion Services does not guarantee the fertility of any stallion, but agrees to process each ejaculate to optimize 24-hour post cool motility, and subsequent fertility. Every effort should be made to inseminate Mare within 24 hours after collection from Stallion. Owner agrees to use all cooled semen provided by this agreement for the mare named in this agreement, and no other.
8. **CTS:** It is imperative that the container be Ken Wold Training Stables & Stallion Services, Ken & Ramona Wold within three (3) days after the date of delivery (i.e. received on Monday must be returned Thursday). Owner will be charged a \$50.00 per day late charge. Late charges will be applied to Owner's account and must be paid prior to any subsequent shipments or Breeders Certificate being released. The shipping container and its components must be returned complete and in good condition. If any of the components (i.e. isothermalizer, coolant cans, ballast bags, etc.) are damaged or missing, the cost of replacement will be charged to Owner's account. Should Owner fail to return the container, Owner agrees to pay for its value of \$500.00. All containers will be insured for \$500.00 upon shipment to veterinarian and should be shipped back to sender with the same amount of insurance. If we do not receive the Equine Express II shipping box by 7 days of you receiving - you will be charged a flat fee of \$50 for the box. Mare owner or veterinarian may not refuse or fail to pick up EEII or Equitainer once it has been shipped.
9. **FTS:** All Dry Shippers must be returned to KWTS&SS within 3 days of receiving. It must be insured for \$2,000. If the Dry Shipper is not received by KWTS & SS within 3 days of receiving a \$100 per day fee will be charged until our office receives the Dry Shipper. FTS will be charged a transfer fee of \$200.00 per request on top of the \$500 Shipping fee.
10. Mare owners who are picking up their semen will be charged \$250 per collection after the first cycle.
11. No shipment will be sent unless all fees are paid. Every contract must have and keep a valid credit card on file.
12. A "breeder's certificate" will be issued upon notification of the birth of the foal only if all fees are paid, including any past due bills on any horse(s) owned by the Owner.

2023 BROTHER JACKSON • STALLION SERVICE CONTRACT

1. The undersigned Mare Owner hereby agrees on this ____ day of _____, 2023, to breed the mare named below to the Stallion BROTHER JACKSON, AQHA Registration number 5313039 for the 2023 season (February 27 – July 14) subject to the following conditions:

- 1. The Stallion Service fee of 500 (plus a non-refundable booking fee of \$500) The \$500 Booking Fee is due and must be paid in full upon execution of this contract. A \$500 fee will be charged for each shipment of semen. See #8 below for exceptions for semen picked up at the ranch. If you are breeding for an Embryo Transfer, Ramona Wold must be notified. Ramona Wold must also be notified of a twin flush within 15 days to provide the second Breeders Certificate. Twin flush must be by natural means and will be charged an additional \$2,000. which includes the booking fee and stallion service fee. * See 20233 FALL FUTURITY SPECIAL CONTRACT Amendment in green on next page for special pricing.
2. This contract contains a "Live Foal Guarantee." A "live foal" is described as a newborn foal which stands and nurses without assistance. If the foal is born dead or does not stand and nurse without assistance, return privileges shall apply only if Ramona Wold is notified within seven (7) days thereof and receives a veterinarian's statement confirming death.
3. The Live Foal Guarantee in this contract is non-transferable and non-assignable. Should the mare be sold or disposed of prior to the birth of the foal the Live Foal Guarantee shall be void. However, Ramona Wold may, in her discretion, (upon application and payment of a new \$500 Booking Fee), continue to honor the Live Foal Guarantee. In the event Ramona Wold agrees to the transfer or assignment of the Live Foal Guarantee under the terms of this contract, then the new owner agrees to be bound by all terms and conditions hereof as far as the same may then be applicable.
4. If the mare does not conceive, aborts, or the foal does not stand and nurse, as stated in the previous paragraph, Ramona Wold, a her election, may re-breed the mare the following year. Return privilege shall apply only to the next normal breeding period. A \$500 booking/administrative fee will be charged for re-breeds and is due prior to breeding or providing semen.
5. A Breeders Certificate will be issued when Ramona Wold has been notified that a live foal has been produced and when stallion fees and all other expenses have been paid in full.
6. Should the Stallion die or become unfit for service for any reason then this contract shall become null and void and both parties are relieved of any further obligation hereunder, and any monies paid by Mare Owner toward the Stallion Fee, with the exception of the non-refundable Booking Fee, shall be refunded to Mare Owner. If mare becomes unfit for breeding. mare owner has the option to change mares upon the discretion of Ramona Wold. However, mare owner will be charged an additional booking fee of \$500. Mare Owner shall pay for all other expenses incurred including but not limited to veterinarian, board etc.
7. Mare Owner agrees that Ramona Wold has not made and does not make any representation or warranty as to the quality or conformation of the foal or that the foal will be free of any infirmity, conformation defect, disease, or inherited trait. KEN OR RAMONA WOLD, AND/OR STALLION OWNER MAKES NO IMPLIED WARRANTIES OR MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE.
8. For semen picked up at the ranch or dropped off locally, first collection is included in the Booking Fee. If additional collections are needed the fee will be \$250 per collection.
9. The parties acknowledge that this agreement is made and shall be entirely performed within the State of California and shall be construed and enforced under the laws of the State of California.
10. The contract shall be binding upon the parties hereto upon execution hereof and the same may not be altered or amended, except by written mutual consent of the parties hereto.
11. A photocopy of both sides of the registration papers of your mare must accompany this contract. The owner recorded on the registration certificate will be recorded on the stallion breeding report.
12. 2023 Contracted mares that did not settle: Please note - A booking fee for re-breed privileges is \$500 and due upon execution of the contract. A shipping fee of \$500 is also due for each shipment of semen for cooled transported semen (or frozen semen if applicable). If you pick up your semen the first collection will be prepared at no additional charge (cooled semen only). If subsequent collections are needed and picked up at the ranch the cost will be \$250 per collection.
13. There is no guarantee of the semen delivery time or quality upon arrival. In the event of insufficient semen on a particular breeding day, we will ship on a first ordered, first serve basis. Depending on the demand, only one dose of semen should be expected.
14. Waiver of Liability: It is understood and agreed by Owner that Ken Wold Training Stables and Stallion Services and Ken Wold or/and Ramona Wold and/or its representatives will not be held responsible for accidents, sickness, injury, or death of Mare and/or her foal. Ken Wold Training Stables and Stallion Services and Ken Wold and/or Ramona Wold will exercise judgment in the care and supervision of said mare and her offspring. Furthermore, the above-named parties shall not be held liable for any negligence or errors and assume no liability whatsoever for Mare and Owner. Owner agrees to hold Ken Wold Training Stables & Stallion Services and its representatives harmless from any and all claims arising from or based upon negligence and gross negligence arising from Mare or representatives being on the premises of Ken Wold Training Stables & Stallion Services. Owner's Horse(s) under the care of Ken Wold and/or Ramona Wold and/or its representatives will not be liable or responsible for any damage, injury or death of breeding farm stallions, employees, veterinarians, or other animals in the care of Ken Wold Training Stables & Stallion Services, Ken Wold and /or Ramona Wold and/or its representatives, whether or not caused by Owner's horse(s).
