2026 Brother Jackson Stallion Breeding Contract

The 2026 Breeding Season is February 11 to July 15, 2026

Collection days are Monday, Wednesday, Friday

A copy of Mare's registration papers must accompany this contract

All contracts/paperwork must be submitted 72 hours prior to ordering semen or pay \$150 rush fee

Booking Fee & Chute Fee are non-refundable

The undersigned Mare Owner agrees to contract one breeding service to BROTHER JACKSON (AQHA Registration #5313039, APHA Registration #1,111,51) for the 2026 Breeding Season, for the following mare:

Breeding Fee - \$1,500.00

Booking Fee - \$500.00 (non-refundable; deducted from the Breeding Fee)

Chute Fee - \$675.00

One On One Integrative Equine, LLC (OOO) has set the following terms:

General Terms:

1. One On One Integrative Equine, LLC (OOO) reserves one breeding to Brother Jackson for the Breeding Fee of \$1,500.00 plus the Chute Fee of \$675.00 for the 2026 breeding season. All payments can be made payable to One On One Integrative Equine, LLC. A non-refundable Booking Fee of \$500.00 will be due when returning signed contract. The Booking Fee will be deducted from the Breeding Fee when semen is ordered, if contract is not already paid in full. Under no circumstances can this contract be sold to another party unless approved by OOO beforehand. Contracts that are not paid in full by July 15, 2026 will be cancelled. Contracts paid in full but not utilized by July 15, 2026 will be cancelled and refunded (minus the \$500 non-refundable Booking Fee and \$675 Chute Fee).
2. Mare shall be healthy and in sound breeding condition. A copy of both sides of the mare's registration papers must accompany this contract. The Owner agrees to breed the mare specified. If a mare change/substitution is needed, the first substitution is free of charge. Each additional mare substitution will have a \$150 charge. To be accepted by OOO, mare substitutions must be made via email, and must be accompanied by the new mare's registration papers and a vet statement. A fine of \$1000.00 will be issued for inseminating any other mare without first notifying OOO via email. A fine of \$1000.00 will be issued for inseminating any mare multiple times without the matching number of paid contracts prior to breeding, or breeding any mare without a current paid (new or rebred) contract.

3. If the stallion should die or become unfit for service prior to the mare getting in foal, the Breeding Fee shall be refunded. Chute Fees are non-refundable.
4. This contract contains a Live Foal Guarantee for the initial contract year when the mare has been confirmed in foal by a veterinarian. It is agreed that a Live Foal is defined as a newborn foal that stands and nurses without assistance. Should any foal which is born to the mare specified in this contract, not stand and nurse, the Owner shall be entitled to a rebreed during the following season. ***This rebreed shall apply only if OOO is notified within seven (7) days of the death of the foal. This notification must be accompanied by a statement from a licensed veterinarian, stating the cause of death of the foal.*** The Owner shall pay Chute Fees for the mare under the same terms set forth in this contract. OOO has the option to require that the mare be brought to OOO for in-house examination and re-breeding. Second year rebreeds will be at the discretion of the Stallion Owner, and additional breeding fees may apply. ***If rebreed is not attempted in the following season (2027), then the rebreed contract will be voided.***
5. Stallion Owner and OOO do not make any warranty as to the quality or conformation of the foal, or that the foal will be free of any heredity or genetic defect, inherited trait, or disease.
6. All rebreed and/or donated contracts will still have the \$675.00 Chute Fee due with the contract. Additional shipping fees may apply.
7. This contract provides for one (1) Breeder's Certificate. If multiple embryos are retrieved from one breeding, or if twins are obtained and carried successfully to term, an additional breeding fee will be assessed. It will be the responsibility of the Mare Owner to notify OOO of the number of embryos transferred. One contract is required for each embryo. If an embryo is frozen/vitrified, the Mare Owner is responsible for all fees associated with this process. It is the Mare Owner's responsibility to notify OOO when an embryo is frozen/vitrified and when it is utilized. If ICSI procedure is used to produce multiple embryos, Additional Embryo Fees will apply. ***Additional Embryo Fees include: Breeding Fee of year each embryo is transferred plus an Office Fee of \$500 each. All fees are due when recipient mare has a positive 45-day pregnancy check.***
8. The Breeder's Certificate will be issued when One On One Integrative Equine, LLC has been notified via email of the birth of the foal. The Breeder's Certificate will not be issued if the account is not paid in full. The Stallion Owner is responsible for signing the Breeder's Certificate.
9. Stallion Owner is not obligated to continue enrollment of the stallion in annual incentive programs past this contract year (2026).
10. If the stallion leaves OOO in the middle of the breeding season, OOO will forward a copy of all contracts and records needed to the Stallion Owner, after which will terminate all mare breeding contracts with OOO.
11. Mare Owner shall hold Stallion Owner and OOO harmless for any accident, injury, theft, disease, illness, or death suffered by the mare and/or foal, or for any claim of damage, loss or injury to any person or personal property, arising out of or connected in any way with On-Site Breeding. In the event of injury or death to the mare and/or foal, the Mare Owner will look solely to his/her own insurance.
12. If it should become necessary for OOO to retain the services of an attorney to enforce the terms of this contract, including but not limited to the collection of any sums due, the Mare Owner will pay OOO all expenses and costs, including attorney fees incurred by OOO in enforcing this contract.
13. Accounts will be billed monthly on or about the 1st of each month. Accounts are due in full within 30 days of billing date. A finance charge of 1.5% per month will be added to all accounts with an unpaid balance. The mare and/or foal will not be released by OOO until the account is paid in full.
14. All US Clients and International Clients must pay with US Funds via Credit/Debit Card (3.5% service fee), Check from US Bank, or Zelle (if pre-approved by OOO).
15. The parties acknowledge that this agreement is made and shall be entirely performed within the State of California, and shall be construed and enforced in accordance with the laws of the State of California.

Shipped Cooled Semen:

1. ***All contracts/paperwork must be in 72 hours prior to ordering semen, or be subjected to \$150 rush fee.*** The Breeding Fee and Chute Fee as specified above must be paid prior to the first semen shipment.

2. The Chute Fee includes the shipment of semen via (1) FedEx Priority Overnight OR (1) Farm Pick-Up OR (1) Airport Counter to Counter shipment (courier fees not included). If an air shipment is requested or required, the Mare Owner's credit card will be charged a \$225 courier charge. Each additional shipment is \$300 and includes (1) FedEx Priority Overnight OR (1) Farm Pick-Up OR (1) Airport Counter to Counter shipment (courier fee of \$225 not included). All fees are subject to change if shipping costs increase or cost is more than anticipated. All fees MUST be paid prior to the semen being released.
3. **Semen orders must be placed by 5pm PST the day prior to collection/shipment. Semen confirmations and cancellations must be made by 8am PST the day of collection.**
4. **Do not order semen via email or answering machine. You must talk to OOO personally and/or receive a text confirmation to order semen.**
5. Collection days are Monday, Wednesday, Friday during the 2026 Breeding Season.
6. On-Farm mares have priority on collections. There is no guarantee of semen delivery within a certain time frame nor the quality of semen at time of arrival. In the event of insufficient semen on a particular collection day, OOO will ship on a first-ordered, first-serve basis. There is no guarantee that cooled shipped semen will be available for a specific day. OOO is not responsible for shipments lost, damaged, or delayed in transit, or condition of frozen semen upon delivery. OOO has no control over the shipment once it leaves OOO facility.
7. Mare owners requesting shipped semen should expect to receive only one dose of semen. Two doses will be shipped if available. If fresh semen is not available, mare owner has the option of receiving frozen semen if available and upon tank availability. Fees for Additional Frozen Shipments are \$350 for FedEx or \$300 for pick-up. \$75 tank filling or top-up charge may be charged. Flights are not available when shipping frozen semen. Any unused frozen semen remains the property of the Stallion Owner and must be returned to OOO at the mare owner's expense.
8. All shipping boxes must be returned to OOO within 7 business days from the date received. After 7 days, the credit card on file will be charged a replacement fee of \$50 for a box or \$300 for an Equitainer. If any contents are damaged or missing, the total replacement fee will be charged.
9. OOO does not guarantee the fertility of any stallion, but agrees to process each collection to optimize 24-hour post cool motility and subsequent fertility. OOO shall not be held liable for contamination of semen during or after shipment, loss of viability, or any costs arising from shipments delayed, damaged, or lost in transit.

Shipped Frozen Semen

1. **All contracts/paperwork must be in 72 hours prior to ordering semen, or be subjected to \$150 rush fee.** The Breeding Fee and Chute Fee as specified above must be paid prior to the first semen shipment.
2. The Chute Fee includes (1) shipment of frozen semen by FedEx 2-day Shipping OR (1) frozen semen Pick-Up. If expedited shipping is needed, additional shipping charges will apply. For each additional shipment, a flat rate of \$350 will apply PLUS All Shipping Costs to and from Your Clinic. Shipping costs vary. A \$75 tank filling or top-up charge may be charged if required.
3. Mare Owner should only expect 1 dose of frozen semen unless otherwise specified and agreed upon. Any unused frozen semen remains the property of the Stallion Owner and must be returned to OOO at the mare owner's expense.
4. **OOO MUST be notified 48 hours prior to requested semen shipment date.** Flights are not available when shipping frozen semen. Frozen semen shipment requests are on a first-ordered, first-serve basis, pending tank availability. Dry shippers are not guaranteed to be available on any particular day.
5. The dry shipping container must be returned to OOO within 7 business days from the date received. After 7 days, the credit card on file will be charged a late fee of \$25/day until the dry shipper is returned. If not returned within 2 weeks, the credit card on file will be charged the current market value of a new dry shipping container. If any contents are damaged or missing, the total replacement fee will be charged. Please use return label provided or ensure a declared value of \$1,000 when returning.
6. **Do not order semen via email or answering machine. You must talk to OOO personally and/or receive a text confirmation to order semen.**
7. OOO is not responsible for shipments lost, damaged, or delayed in transit, or condition of frozen semen upon delivery. OOO has no control over the shipment once it leaves the facility.

Canadian Shipments:

1. **All contracts/paperwork must be in 72 hours prior to ordering semen, or be subjected to \$150 rush fee.** The Breeding Fee and Chute Fee as specified above must be paid prior to the first semen shipment.
2. The Chute Fee includes (1) shipment of fresh or frozen semen by FedEx Shipping.
3. Canada Fresh Semen Fees: additional fee of \$300 each for FedEx Priority International PLUS Health Certificate charges, and must be paid prior to shipment.
4. Canada Frozen Semen Fees: additional fee of \$400 each for FedEx Priority International PLUS Health Certificate charges, and must be paid prior to shipment.
5. All Canadian shipping fees are subject to change.
6. Please coordinate international semen shipping with OOO in advance of requesting semen.

On-Farm Breeding:

1. All contracts/paperwork must be completed and in before or upon arrival of mare to OOO. This includes haul-in mares and mares staying at OOO for breeding.
 2. The Breeding Fee and Chute Fee must be paid prior to or upon arrival of the mare to OOO. Mare Owner must include a copy of the mare's registration papers.
 3. The Chute Fee of \$675.00 is to be paid by Mare Owner to OOO prior to any reproductive or breeding services, and is non-refundable. The Chute Fee includes all semen collections and artificial inseminations performed at OOO up to three (3) breeding cycles. The Chute Fee does not include board, breeding soundness exams, ultrasounds, special insemination procedures, uterine treatments, sedation, hormone therapies, ovulatory drugs, diagnostic tests, etc. If the mare does not settle within three breeding cycles, then an additional fee of \$300 will be assessed for each additional cycle.
 4. Embryo Transfers – Embryo transfers are not currently being offered at OOO. Special arrangements can be made between Mare Owner and OOO to flush embryos. All arrangements and fees must be specified and agreed upon prior to planning an embryo transfer.
 5. Medical and husbandry history including vaccinations, deworming, and farrier care must be provided upon mare's arrival. Vaccinations must be current within 90 days and shall include Encephalitis, Tetanus, Influenza, Rhinopneumonitis, West Nile, Rabies and Strangles (optional). Mares arriving at OOO with inadequate vaccination/deworming history will be vaccinated and/or dewormed at Mare Owner's expense at the time of arrival. The Mare Owner authorizes OOO to provide the mare/foal with any veterinary or farrier services deemed necessary or proper for the mare/foal's well-being while at OOO, at the Mare Owner's expense. OOO agrees to attempt to contact Mare Owner should any emergency with the mare/foal occur.
 6. OOO veterinarians will reproductively evaluate the mare for normal breeding conditions and perform other such services as OOO, in its sole judgement, deems necessary, and the Mare Owner shall pay the expenses for such services. These services include, but are not limited to, deworming, vaccinations, other preventative measures, farrier services, hauling fees, treatment for uterine infections, breeding soundness exams including uterine culture/biopsy, treatment for cuts/abrasions, and other emergency treatments.
 7. OOO agrees to provide board, feed, and general care services for the mare covered in this agreement. The Mare Owner agrees to pay OOO's established rates. All board, veterinary/breeding procedures, and/or medications are billed monthly and payable upon receipt.
 8. Mare Owner agrees that he/she has made him/herself familiar with the facilities at OOO and approves of the care provided. If any other services are required or requested by Mare Owner, they shall be specified in writing to OOO upon mare arrival.
 9. OOO shall attempt with reasonable diligence to settle the Mare. If for any reason the mare does not settle, the Mare Owner will hold OOO harmless.
